## **INFORMATION ON DEMARCATION**

- Request for demarcation must be submitted by the plot owner of the person appointed as a power of attorney. Supporting proof documents must be submitted if the person is a power of attorney.
- ❖ All other works shall be commenced within 14 (fourteen) days from the notified date of completion of demarcation after obtaining the required approvals from HDC.
- There is a possibility of change in the demarcation points due to public disruption or construction works of adjacent plots.
- ❖ In case there is no land registration, a document identifying the owner of the plot must be submitted.
- ❖ The applicant will be notified when the demarcation is completed within 10 (ten) working days from the second day of application.
- ❖ The owner will be notified within 10 (ten) days if the survey cannot be completed before the expiry of the deadline. (General causes are weather constraints and plot debris, making it difficult to demarcate).
